

## Dog Training Service Agreement

This agreement is between \_\_\_\_\_ (hereinafter referred to as “client”) and Infinite Dog Training (hereinafter referred to as “trainer”) with dog legally owned by client with name \_\_\_\_\_, breed \_\_\_\_\_, age \_\_\_\_\_.

Trainer agrees to provide private lessons/consultations and/or board and train services for the following nonrefundable fees:

Private lessons or consultations per hour \$ \_\_\_\_\_

Client acknowledges trainer may take client's dog to locations other than the trainer's facility or home for the purpose of training and behavior modification.

Trainer will make every reasonable effort to help client achieve training and behavioral modification goals and will educate client so client can continue with training and behavioral modification after and/or in between time with trainer. Trainer however makes no guarantee of dog's behavior nor performance as a result of providing training and behavior modification. Trainer also makes no guarantee as to the amount of time it will take to achieve client's goals.

Client understands they are responsible for and shall engage in the prevention and treatment of fleas and ticks, heartworms, intestinal parasites, and illnesses that can be vaccinated against and will hold the trainer harmless of any such infections should they occur. And the client understands that Rabies vaccination is required by law and will furnish the trainer with a copy of an up to date Rabies certificate. The client also agrees their dog is in good health and condition and is able to engage in training activities. If trainer expresses concerns for the dog's health or fitness, client agrees to investigate with a veterinary visit at the client's expense.

Suggestions given to client by trainer are voluntary and the client will not hold the trainer responsible should any harm or injury occur to human or animal (including the client's dog) while engaging in trainer suggestions. Client further understands and acknowledges that their dog will be engaging in physical activity such as running, jumping, etc. that is not free from risk of injury; additionally the client may be engaging in physical activity during dog training lessons given by trainer at trainer's facility, in public places, or at client's home and that the activity and environment may not be free of hazards or risk of injury to client (or client's family if they are participating). Accordingly, client hereby warrants and promises that client shall indemnify and hold harmless the trainer for any and all such injuries. Client warrants they have disclosed all aggression observed in their dog toward humans or other animals. Client agrees they are fully responsible for their dog's behavior at all times and will not hold the trainer responsible for any actions of the dog that cause property damage or harm to humans or animals. If the client's dog causes property damage or bites or injures any animal, or human (including but not limited to the trainer) then client agrees to pay all resulting losses and damages suffered or incurred; and to indemnify the trainer from any resulting claims, lawsuits, losses, expenses, demands, or attorney fees.

This agreement supersedes all prior discussions, representations, warranties and agreements; and expresses the entire agreement between client and trainer regarding matters as described above. Client acknowledges that trainer has not warranted, guaranteed, promised, or represented that client's dog will never bite or be dangerous in the future; that client's dog will not exhibit other problem behaviors; or that the results of the training will last for a certain length of time.
